The objective of this portfolio is to provide investors with steady compounding of capital overtime through a concentration of holdings in companies of the highest quality. Growth of income is more important than level of income.

Fund Strategy

The portfolio will invest in assets in liquid form and in shares across all economic groups and industry sectors of the JSE Securities Exchange South Africa as well as across the range of large, mid and smaller cap shares and such other financial instruments as may be permitted by the prevailing regulations. This will be a highly focused quality equity portfolio concentrating on a maximum of 20 securities of the highest quality. The portfolio may also invest in collective investment schemes in property as well as any other securities that the Act may allow from time to time. When investing in derivatives, the manager will adhere to the prevailing regulations.

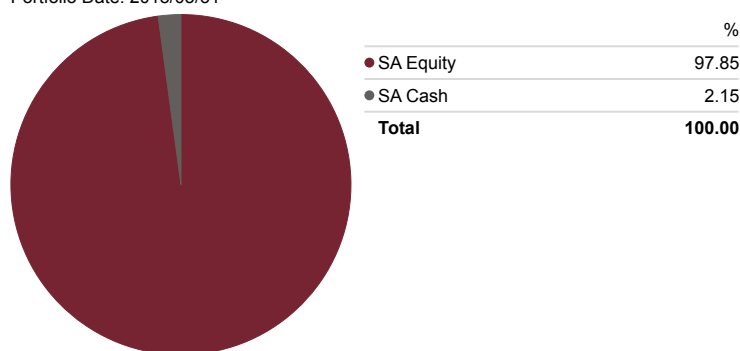

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. Glossary Terms

Annualised total returns

Annualised return is the weighted average compound growth rate over the period measured.

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to "share" in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Sharpe ratio

The Sharpe ratio measures risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the amount of expected volatility in an investment.

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

31 March 2018

The first quarter of 2018 saw a sharp recovery in interest rate sensitive stocks (retailers and financials) driven by improving confidence in South Africa, avoidance of a ratings downgrade by Moodys, SARB rate cuts and the release of positive economic data. Property stocks did not participate in this recovery largely due to the uncertainty created by accounting irregularities within the Resilient group of companies (Fortress, Greenbay and Resilient). These counters were down between 60% and 70% over the quarter and contributed positively toward the fund relative return as it has no exposure to the property sector. Capitec and PSG lagged the banking sector due to heightened uncertainty created by a negative report released by short-seller Viceroy Research. This detracted from fund returns; however, the allegations in the report appear to lack credibility judging by management's response to the report and a reversal of some of its losses in recent weeks. Profit taking in Discovery and regulatory uncertainty associated with British American Tobacco further detracted from fund performance. However, we remain confident in the quality of these businesses and continue to hold them in the portfolio.

Going forward, we expect the recent resurgence of market volatility to continue as investors price in further rate hikes by the Fed and the risk of a trade war between China and the USA intensifies. Within this context, we believe that cash-rich, quality companies will provide the comfort investors require to navigate through such uncertainty. SA Inc stocks are well positioned to continue to benefit from the positive macroeconomic backdrop and lower political uncertainty. During the quarter, Naspers' decision to sell a 2% stake in Tencent and allocate the proceeds toward acquisitions instead of buybacks was received negatively by the market. We believe that the stock is oversold at current levels as a result and we therefore have increased our allocation to Naspers in the portfolio.
