The objective of this portfolio is to provide investors with steady compounding of capital overtime through a concentration of holdings in companies of the highest quality. Growth of income is more important than level of income.

Fund Strategy

The portfolio will invest in assets in liquid form and in shares across all economic groups and industry sectors of the JSE Securities Exchange South Africa as well as across the range of large, mid and smaller cap shares and such other financial instruments as may be permitted by the prevailing regulations. This will be a highly focused quality equity portfolio concentrating on a maximum of 20 securities of the highest quality. The portfolio may also invest in collective investment schemes in property as well as any other securities that the Act may allow from time to time. When investing in derivatives, the manager will adhere to the prevailing regulations.

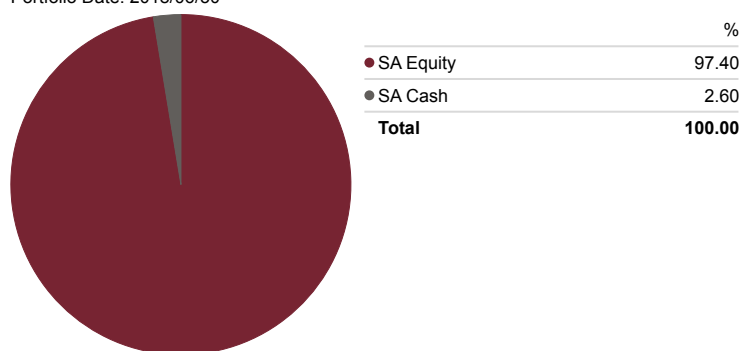

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. Glossary Terms

Annualised total returns

Annualised return is the weighted average compound growth rate over the period measured.

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to "share" in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Sharpe ratio

The Sharpe ratio measures risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the amount of expected volatility in an investment.

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 30 June 2018

South African equities, together with other Emerging Markets, suffered collateral damage from the recent trade war created by US President Donald Trump against China. As a result, the quarter was characterised by sizable movements in SA and EM stock prices, bond yields and currencies. The South African Rand weakened by 16% in the quarter to become one of the three worst performing currencies globally. Such movements were exacerbated by a reversion in the positive sentiment associated with the election of a new President. South African 10 year bond yields also rose from 8.0% to 8.9% demonstrating a loss of confidence in SA. As a result, domestic shares such as retailers, banks and telcos experienced severe selling pressure. Quality stocks such as Vodacom and Mr Price fell as much as 20% in the quarter amidst the sell-off. The only place to hide was in Rand hedges such as BHP Billiton, Sasol and Mondi PLC which were up 32%, 24% and 15% respectively during a quarter where the market was largely flat. Besides Mondi and Richemont, the Rand hedges in our portfolio such as British American Tobacco did not buffer against these movements as we would have expected them to in a ZAR weakening environment. However, these have started to rally post the quarter end which will enhance performance going forward. In the long term, we believe that high quality companies possess the fundamental characteristics that will allow them to create shareholder value despite such transient macroeconomic movements. We therefore sustain our portfolio positioning and take advantage of the period of high volatility to further high grade the portfolio by allocating more weight to quality counters that have been inadvertently sold off in the quarter (e.g., Vodacom).
