When investing in derivatives, the manager will adhere to the prevailing regulations.

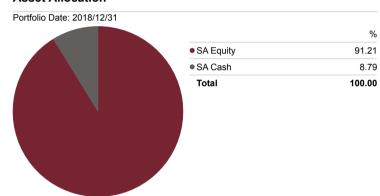

Risk Profile

Aggressive

Glossary Terms

Annualised total returns

Annualised return is the weighted average compound growth rate over the period measured

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to *share in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Sharpe ratio

The Sharpe ratio measures risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the amount of expected volatility in an investment.

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 31 December 2018

Equity valuations in South Africa remain close to 6 year lows driven by the global concerns around a slowing China and its contagion effect on global cyclical currencies, developing market equities and commodities. This 'China risk factor' is responsible for the heightened volatility and uncertainty associated with the SA market with large price movements occurring around positive or negative news releases related to US-China trade tensions. In addition, the local economy has further contributed to this volatility by persistently delivering sub-2% GDP growth and higher unemployment. Controversial policies around land reform create further uncertainty for foreign investors. Within this context, 'SA Inc' stocks have been serial underperformers regardless of their quality. The only place to hide was in mining companies which are global cyclicals; In addition, miners benefitted from redirecting capital expenditure toward paying down debt and resuming dividend payments in an environment supported by a weaker ZAR. Going forward, we believe that tapering down of global growth will redirect investors to cheap high quality domestics with lower leverage ratios. Over the past few months, the fund took advantage of the high level of volatility in SA markets to enter into news positions in Bid Corp, Mondi and RMB Holdings at attractive valuations. These positions enable: 1) greater levels of diversification and 2) offer attractive dividend yields to the quality investor. We sold out completely from British American Tobacco (BTI) during the period following structural change in their dynamics of the global (especially US) tobacco industry. Top contributors to return in the portfolio came from defensive quality stocks offering high cash conversion and strong dividend yields (Bidvest, Clicks and Spar).
