The objective of this portfolio is to provide investors with steady compounding of capital overtime through a concentration of holdings in companies of the highest quality. Growth of income is more important than level of income.

Fund Strategy

The portfolio will invest in assets in liquid form and in shares across all economic groups and industry sectors of the JSE Securities Exchange South Africa as well as across the range of large, mid and smaller cap shares and such other financial instruments as may be permitted by the prevailing regulations. This will be a highly focused quality equity portfolio concentrating on a maximum of 20 securities of the highest quality. The portfolio may also invest in collective investment schemes in property as well as any other securities that the Act may allow from time to time. When investing in derivatives, the manager will adhere to the prevailing regulations.

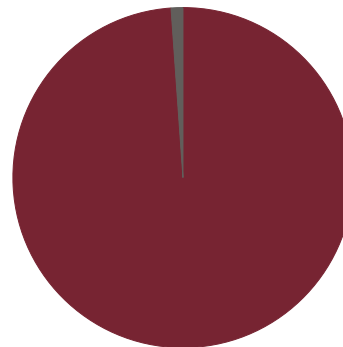

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.

Glossary Terms

Annualised total returns

Annualised return is the weighted average compound growth rate over the period measured.

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to 'share' in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Sharpe ratio

The Sharpe ratio measures risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the amount of expected volatility in an investment.

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 31 March 2020

The first quarter of 2020 will be remembered as being one of the worst ever globally with the FTSE JSE Shareholder Weighted Index down 23% and the MSCI World Index down 21%. The strong reversion was driven by the uncertainty created by the rapid spread of the coronavirus globally. Unlike past crises such as the financial crisis in 2009, the epidemic also included a humanitarian crisis with the virus infecting almost 2m people and the death toll exceeding 120,000 people. Amidst such unusual conditions, there were not many places to hide on the JSE. A 27% weakening of the Rand favoured Rand hedge stocks with low levels of gearing and resilient cash flow streams. These include Naspers, Prosus, Reinet and British American Tobacco. Certain recession proof, quality names domestic such as Vodacom, Shoprite and Clicks also proved extremely defensive and registered positive returns over the quarter. Our exposure to these names including more than a fifth of the portfolio weight allocated to Naspers and Prosus allowed out fund to fall less than the market by 3.6%. The focused funds only invests in the most resilient business models available on the JSE and we continue with this defensive positioning given that the coronavirus is still expected to peak in South Africa over the next 2 months while Northern Hemisphere markets are into their recovery phase. We have also taken the opportunity to increase high grade the portfolio with quality Rand hedges such as Anglo Platinum where feasible. Longer term, we believe South Africa will have certain difficult, possibly unpopular, decisions to make to revive the economy from this low point. We watch closely as any change toward a pro-growth stance will revive the fortunes of quality domestic companies in the long term.
