Fund Strategy

The portfolio will invest in assets in liquid form and in shares across all economic groups and industry sectors of the JSE Securities Exchange South Africa as well as across the range of large, mid and smaller cap shares and such other financial instruments as may be permitted by the prevailing regulations. This will be a highly focused quality equity portfolio concentrating on a maximum of 20 securities of the highest quality. The portfolio may also invest in collective investment schemes in property as well as any other securities that the Act may allow from time to time. When investing in derivatives, the manager will adhere to the prevailing regulations.

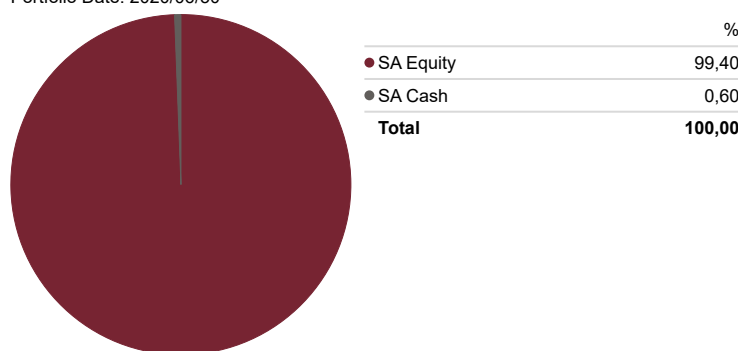

Risk Profile

Aggressive

You can afford to take on a higher level of risk (i.e., have a greater exposure to equities) because of your investment time horizon and/or your appetite for risk. Glossary Terms

Annualised total returns

Annualised return is the weighted average compound growth rate over the period measured.

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to 'share' in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Sharpe ratio

The Sharpe ratio measures risk-adjusted performance of an investment or portfolio. It measures the amount of risk associated with the returns generated by the portfolio and indicates whether a portfolio's returns are due to excessive risk or not. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Standard deviation

Standard deviation (also called monthly volatility) is a measure of how much returns on an investment change from month to month. It is typically used by investors to gauge the amount of expected volatility in an investment.

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk' and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 30 June 2020

The second quarter of 2020 can only be described as one of extreme volatility on the JSE due to the uncertainty associated with the coronavirus pandemic and associated lockdowns, a Moody's downgrade of SA's credit rating below investment grade and the launch of unprecedented levels of fiscal and monetary stimulus programmes across most major nations. To illustrate the volatility, the average stock within the FTSE JSE SWIX index would have delivered a maximum gain of 55% and maximum drawdown of 23% during the quarter which is the highest that we have observed since 2009. The former refers to the return an investor could have achieved should he or she have had perfect hindsight and bought at the lowest price and sold at the highest price during the quarter. The latter is the greatest loss achieved should the investor have bought at the highest price and sold at the lowest price during the quarter. This extended to both large and mid/small cap stocks. For example, an investor with perfect timing could have achieved a 410% return investing in Sasol but could have also experienced a 26% drawdown should his/her timing have been incorrect.

The FTSE JSE SWIX index delivered a 23.6% return for the quarter amidst the volatility largely due to the stimulatory measures by the US, Europe, Japan and China which are at a level not seen since World War 2. The majority of these returns were derived from Naspers, Prosus, Sasol and diversified, gold and platinum mining companies. Such companies are either geared to stimulatory actions or, as is the case with Naspers/Prosus, have 'stay-at-home' business models which are largely unaffected by the coronavirus pandemic. We are pleased that the fund used both Q1 and Q2 2020 to increase our weights in these sectors through new positions in Kumba Iron Ore and Amplats as well as increased weight allocated to Naspers, Sasol and Prosus. The fund underperformed during the quarter largely due to its lack of exposure to gold miners. We are comfortable with this positioning going forward as: 1) gold has reached its previous peak of USD 1800/ounce which it is unlikely to maintain as uncertainty levels dissipate (as was the case during the 2009 financial crisis) and 2) we believe that the quality domestic companies within our portfolio have reached decade lows in terms of valuation and have a high probability of rebounding strongly over the next year. We are, however, concerned about the impact of an extremely strict lockdown on the SA economy and employment levels and therefore focus the domestic equity component of our portfolio only on those business who have balance sheets that can weather the storm and business models that enable market share gains as weaker players exit their respective industries.
