The portfolio may invest in participatory interests of underlying unit trust portfolios. The portfolio may also invest in collective investment schemes in property as well as any other securities that the Act may allow from time to time. 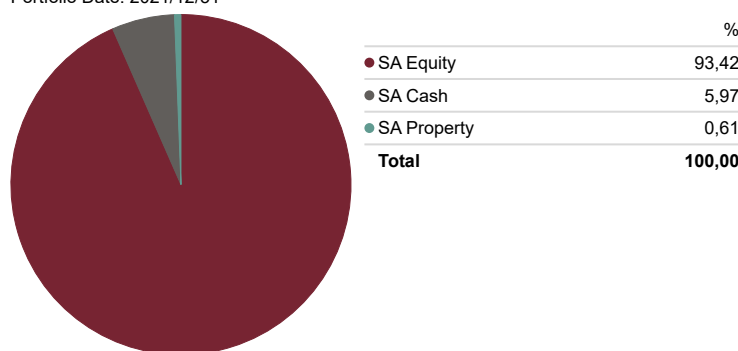

Risk Profile

Aggressive

Glossary Terms

Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to 'share' in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

Volatility

Volatility is a measure of 'risk', and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

Portfolio Manager Comment

As at 31 December 2021

During the fourth quarter of 2021, the recovery of our portfolio was briefly interrupted by a rebound in PGMs during the month of October followed by a rebound in gold stocks during the month of November. Although we hold both Amplats and Northam in an overweight position, we maintain an overall underweight position in resources. While we remain of the view that mining stocks do not exhibit the highest hallmarks of quality, we are confident in our ability to extract alpha from our stock picks within this sector. We do so by selecting those stocks with superior capital allocation and trade at reasonable valuations. In the case of Northam, we believe that the decision to bid for the RB Plats was erroneous and that the stake will eventually be sold. The proceeds will return to shareholders. We remain comfortable with a zero weighting in gold stocks as we believe that the run up in gold counters was opportunistic rather than structural in nature. Given the negative correlation of gold stocks with interest rates, we expect that the structural challenges faced by gold stocks will resurface because of anticipated rate hikes by the Fed. The timeline for the rate hikes has also been expedited which means the compression of gold prices will occur sooner than investors were anticipating.

The recovery in the relative performance of our portfolio continued during the month of December as precious metals once again began to weaken. A high percentage of stocks held in the portfolio recorded 52week highs during the month of December. These included Capitec, Clicks, Richemont, Dischem, Equites, Hudaco, Italtile, Massmart, Motus, MTN, Netcare, Ninety-One, Pik n'Pay, PSG, Raubex, Shoprite, South 32 and Stadio. Going forward, we believe the High-Quality stocks in our portfolio remain well positioned to counter the negative sentiments caused by the uncertainty surrounding both the timing and number of interest rate hikes to follow.
