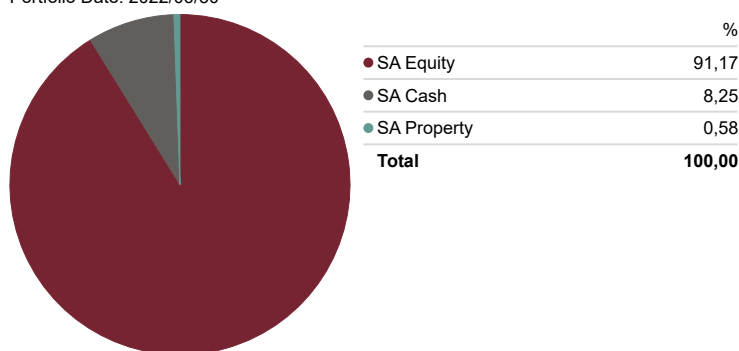

## Risk Profile

### Aggressive

## Glossary Terms

### Capital growth

Capital growth is the profit made on an investment, measured by the increase in its market value over the invested amount or cost price. It is also called capital appreciation.

### Equities

An equity or share represents an institution/individual's ownership in a listed company and is the vehicle through which they are able to 'share' in the profits made by that company. As the company grows, and the expectation of improved profits increases, the market price of the share will increase and this translates into a capital gain for the shareholder. Similarly, negative sentiment about the company will result in the share price falling. Shares/equities are usually considered to have the potential for the highest return of all the investment classes, but with a higher level of risk i.e. share investments have the most volatile returns over the short term. An investment in this type of asset should be viewed with a 7 to 10 year horizon.

### Fundamental analysis

This is a method of evaluating a share that involves attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the share's value, including macroeconomic factors (like the overall economy and industry conditions) and company-specific factors (like financial statements, cashflow and management).

### Total Expense Ratio (TER)

This is the total costs associated with managing and operating an investment (excluding administration, financial planning and servicing fees). These costs consist primarily of management fees and additional expenses such as trading fees, legal fees, auditor fees and other operational expenses. The total cost of the fund is divided by the fund's total assets under management to arrive at a percentage amount, which represents the TER.

### Volatility

Volatility is a measure of 'risk', and refers to the extent to which the price of an investment or fund fluctuates over a certain period of time. Funds with a high volatility usually offer the potential for higher returns over the longer term than low volatility funds.

**Portfolio Manager Comment**

**As at 30 June 2022**

The second quarter of 2022 saw a continuation of the recovery of our portfolio. We remain of the view that mining stocks do not present with the best hallmarks of quality, but we are confident in our ability to extract alpha from our stock picks within this sector, by selecting those stocks with superior capital allocation. During the last quarter, we held Thungela, South32 and BHP Group in overweight positions, while maintaining an overall underweight position in resources. This positioning was instrumental in driving our positive relative outperformance over the quarter. Given the negative correlation of gold stocks with interest rates, we expect that the structural challenges faced by gold stocks in an inflationary environment will continue, as has been the case in the last few months. As a result, our portfolio continued to demonstrate a strong aversion to the gold counters. Sasol was the major detractor within the resources segment, as the stock continued its rally on the back of global macro-economic tailwinds.

The recovery in the relative performance of our portfolio was further aided by our holdings of global defensives. We were overweight Richemont, Anheuser-Busch and British American Tobacco and these stocks contributed positively to our relative outperformance in the second quarter. We also initiated overweight positions in Absa and Nedbank, in anticipation of the looming interest rate hikes. These two banks have a strong endowment effect, which allows them to benefit significantly from rising interest rates. We expect First Rand to be a beneficiary, albeit to a lesser extent. While we remain cognisant of the negative impact rising interest rates can have on the performance of Capitec, we are confident that company has healthy growth prospect which can offset the rate impact. Going forward, we believe the High-Quality stocks in our portfolio are all well positioned to outperform given their inherent pricing power and defensiveness. We also expect to see increasing volatility among the resource stocks, which should be beneficial for our portfolio.
